Evidences for a Volcanic Province in the Central Indian Basin

Abstract: Based on various lines of evidence such as the widespread occurrence of basalts, pumice, volcanic glass shards and their transformational products (zeolites, palagonites, and smeetite-rich sediments), we suggest the presence of a volcanic province in the Central Indian Basin (CIB). In addition to the rocks studied, the occurrence of many morpho-tectonic features such as seamounts, abyssal hills and major fracture zones at 73°E, 75°45'E and 79°E, have helped in correlating and in deciphering the source of the rock types. Further, the large manganese nodule fields in the CIB are seen to occur in conjunction with the volcanic materials, since the latter forms nuclei and substrates for ferromanganese deposits. It is concluded that a spatial relation exists between the occurrence of the volcanic materials and the ferromanganese deposits in the CIB.

INTRODUCTION

The source and magnitude of volcanic activity at local or regional scale can be deciphered by a study of volcanic products spread over the terrain but in deep-sea areas, particularly in the Central Indian Basin (CIB) such investigations are sparse.

An area of 4.2 million sq.km situated between latitudes 0° and 20° S and longitudes 70° and 84°E, covering most of the CIB was selected for this study. Sampling was carried out at 1840 stations during 46 cruises and more than 10,000 freefall grab samplers were deployed. The materials recovered largely include sediments, volcanic rocks, ferromanganese encrustations and weathered and their transformational products.

This report aims to provide details about the occurrence, type, and distribution of various volcanic materials in the CIB based on which a volcanic province is demarcated.

RESULTS AND INTERPRETATIONS

The CIB is bordered on three sides by the Ninety East Ridge, Mid-Indian Ridge and its southeastern and southwestern extensions; whereas to the north it is open to the influence of Ganges-Brahmaputra riverine sediments input.

Fig.1, shows a comprehensive map of distribution of pumice, and zeolites, together with major tectonic features and areas of potential nodule deposits in the CIB.

The CIB is mainly floored by siliceous sediments from 10°-15° S while beyond 15°S pelagic brown clays dominate. Small zones of terrigenous and calcareous sediments are also present to the north and west, respectively. Based on these sediment types and their distribution pattern, four distinct zones are identified (Fig.2).

These zones express distinct characteristics in terms of their seafloor morphology, tectonic features, occurrence and distribution of volcanogenic materials, and authigenic minerals such as zeolites and manganese nodules (Table I).

Although the occurrence of pumice extend from 10°-19°S and 68°-84°E (average water depth is 5000 m) the main concentration is in central deeper parts of the CIB. This concentrated zone closely follows the major tectonic features in the basin.

Pumice forms nucleus for nodules with very rough to rough surface textures and an apparent relationship was observed between the nucleus type and surfaces texture of nodules in the CIB. Such an observation convinces us to

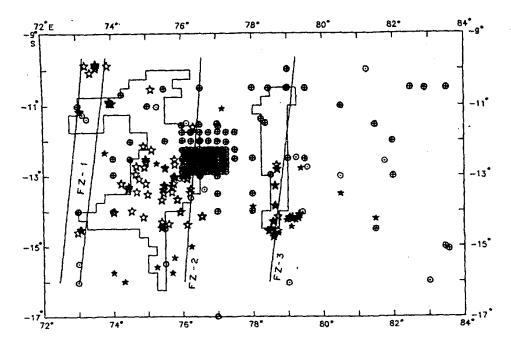


Fig.1. Comprehensive location map of morpho-tectonic features, potential manganese nodule fields and distribution of pumice and zeolites in the Central Indian Basin. FZ-1, FZ-2, FZ-3 are Fracture Zones; open stars are seamounts recorded by multibeam swath system; filled stars are seamounts recorded by single beam echosounding; circles with plus are locations of pumice; and circles with dot are locations of zeolites.

conclude that pumice clasts play a vital role in deciding the shape and size of nodules. A paucity of manganese nodules to the north of 10°S was believed to be due to rapid influx of terrigenous sediments from the Ganges and Brahmaputra (Nath et al. 1989), whereas we attribute this paucity to the limited occurrence of pumice and other volcanics in this region (Table I). Northern boundary of pumice field is delimited at around 10°S. To the south of this region distribution of paramarginal grade nodules dominate. Such juxtaposed fields of pumice and nodules suggest a close relationship between the two.

Frick and Kent (1984) proposed that pumice in and around the Indian Ocean was largely derived from 1883 eruption of Krakatoa. Svalnov (1981) reported a pumice of 20 cm size derived from Krakotoa near the Ninety East Ridge and suggested that bigger pumice west of this is not possible. Frequent occur-

rence of pumice of various sizes, especially the larger ones (~30 cm) in the CIB precludes their origin and/or derivation from Krakatoa and suggest an *in situ* origin (Iyer and Sudhakar, 1993a).

Large pumice clasts in the CIB are deemed to be derived locally as hot pumice near the eruptive source and floated for short times. Occurrence of pumice deposit in the vicinity of fracture zones, seamounts, and abyssal hills probably suggests a morpho-tectonic control. We envisage that pumice may be locally derived during eruptive phase of seamount(s) and/or due to reactivation along the fracture zones.

Three types of pillow basalts and basaltic fragments are identified: fresh, moderately altered and highly altered, which occur abundantly on the summits and flanks of the scamounts and abyssal hills. Numerous seamounts and abyssal hills seem to have served as conduits for outpourings of basaltic magma which

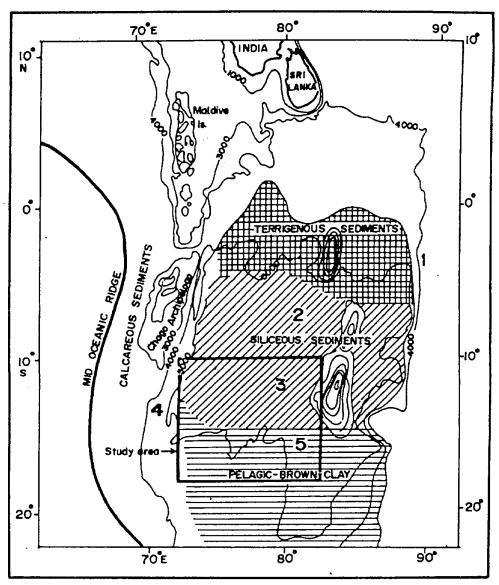


Fig. 2. Map showing description of important parameters (discussed in Table I) in four sediment zones of the Central Indian Basin. Area-1 terrigenous sediments, Area-2 & 3 are siliceous sediments, Area-4 calcareous sediments and Area-5 pelagic-brown clay. Area-4 is not discussed in Table I due to lack of data.

on subsequent cooling and crystallization formed pillow lavas. Such central type of volcanic eruptions might have been either episodic or as single eruptions. Subalkali basalts near 79°E fracture zone were spilitized to varying degrees. These were suggested to be similar to fissure type of eruptions, indicating a fault-controlled basaltic field (Karisiddaiah and Iyer, 1992).

Unique indurated slabs were recovered in

the CIB. Based on their dominant mineralogy of phillipsite-harmotome group, we termed them as 'zeolitites' (Iyer and Sudhakar, 1993b). Entrapment of pumice were noted within these slabs. Zeolitic materials form nucleus and substrate for ferromanganese oxide deposition. Such slabs are derived by a series of chemical reactions, wherein volcanic precursors are transformed into palagonites and zeolites.

Based on distribution of zeolites in sedi-

ments, Venkatarathnam and Biscaye (1973) suggested that during Cretaceous-Eocene times, local silicic volcanism had existed in the Indian Ocean. Vallier and Kidd (1977) indicated that abundant silicic volcanic glass was derived during Pliocene and Pleistocene times and that a strong input of silicic glass did not begin until the late Miocene.

Ferromanganese crusts were recovered from different physiographic settings. Suspected hydrothermal input (Iyer, 1991) and faster hydrogenous growth rates (Shyam Prasad, 1994) were suggested for the growth of these crusts. These findings suggest that there are areas in the CIB where low temperature hydrothermal activity prevailed.

Montmorillonite and Fe-rich montmorillonite, derived by the alteration of volcanic materials are reported (Rao and Nath, 1988). Considering the average Ti/Al quotient, excess SiO, and Ba, from the sediment chemical data of Nath et al. (1989), it is observed that SiO, is high in siliceous sediments than expected, even after accounting for an average excess silica of ~28%. We believe that this high amount of SiO, may be due to presence of andesiticrhyolitic glass shards and pumice fragments in the sediments. These findings are corroborated by the average SiO₂ (-62%) composition of the pumice lying on these sediments (lyer and Sudhakar, 1993a). Further, chemical composition of pumice indicate two types, viz., trachyandesite and rhyolitic types (Manuscript under preparation).

Enrichment of Ba content in the CIB sediments was solely attributed to dissolution residue by Nath et al. (1989). But it has been opined that Ba also occurs by dehydration and cation exchange with effusive lava and with volcanic particulates or through hydrothermal transport from the magma and that Ba is intimately distributed between the seawater and

the exchangeable cation sites of harmotome (Arrhenius and Bonatti, 1965). We suggest Ba input to the CIB sediments/zeolites to be from more than one source i.e., biological, hydrothermal, diagenetic or a combination of these. High Ba contents (> 700 ppm) in pumice further explains Ba enrichment in the CIB sediments.

A valuable and direct evidence for in situ volcanism is the occurrence of volcanic magnetite spherules in association with silicic glass shards in the basin recovered from the vicinity of a large seamount (M. Shyam Prasad, pers. comm.). Radiolarian biostratigraphic studies indicate an age of ~10 Ka for the associated sediments. Thus, it is inferred that in the recent past there has been volcanic eruption(s) in the CIB.

Based on the above observations we summarize that (a) fracture zones and seamounts are possible source for pumice deposits, (b) basalts are ubiquitous, especially in the vicinity of seamounts and fracture zones, (c) zeolites had their origin from volcanic precursors, (d) nucleating agents for nodules are volcanic materials and their derivatives, (e) nodule deposits of first generation mine-sites occur in juxtaposition to that of pumice field and (f) fields of pumice and nodules suggest a tectonic control to their distribution.

Hence, it is inferred that the occurrence of smectite-rich sediments, association and distribution of zeolites, presence of basalts, volcanic glass shards and pumice imply a province of widespread volcanism and formation of various authigenic minerals in the CIB.
