BIOLOGICAL AND GEOPHYSICAL ASPECTS OF COASTAL STRUCTURES

Geological processes, that occur in the nearshore environment: The nearshore, environments have been strongly influenced by sealevel changes throughout the geological history. Much of the shallow-water region is also strongly affected by waves, tides and shallow currents. Thus the sedimentary history of the shelves and nearshore environments reflect the ever-changing relationship between tectonic subsidence, sea level oscillations and the dynamic processes acting at these water depths. These environments also lie within the photic zone so they are influenced by biological processes and productivity that do not occur in most other parts of the ocean.

The near shore environments and the continental shelves have played a major role through time in the storage or redistribution (or both) of land derived, or ferrigenous sediment to deeper ocean. Rock weathering on land produces matter like sand and clay as well as dissolved material. This matter is carried to the continental margins and some is deposited in the deep sea. It was estimated that some 250×10^{14} qm of material is carried each vear oceans. Rivers carry about 85 to 90 percent of this material, ice transportation accounts for about 7 percent, ground water 1-2 percent and wind less than 1 percent. About percent of river load is particulate matter and the remainder of dissolved form. This vast amount of terrigenous

sediment delivered to the marine environment is discharged by a few rivers.

Because of the diversity of oceanographic influences in marine areas it is not surprising that there much diversity of sedimentary environments grading into each Sands are generally restricted to the shore maximum depths of about 20 m while muds are not distributed much beyond 30 km from the shore line, except where is more. The development of shore line sedimentary environments is a function of numerous parameters including rate of influx of terrigenous sediment, tidal regime, exposure to waves, current patterns, climate and tectonism. character of the modern shoreline deposits reflects the balance between the rate of injection of sediment and ability marine processes to redistribute the material. balance in turn determines the chemical character of shelf sediments. Where terrigenous input is large, terrigenous sediments dominate (clastic shore lines), as terrigenous sediment input declines, carbonate sedimentation begins become important and in some areas it becomes dominant. (carbonate shore line).

Sediment disequilibrium of Modern Coastal zones

The character of the world's continental shelves varies considerably in structure, sediment type and topographic evolution. The development of these shelves has ranged from the truncation of older rocks to the deposition of roughly

conformable sediment sequences of Mesozoic to Recent age. The broad, flat character of the shelf has resulted from erosional activity related to a series of transgressions and regressions. Both erosion and sedimentation are concentrated in the nearshore areas, and the repeated sea level migrations have leveled the margins forming the shelf surface.

During this transgression the shore migrated so rapidly that rates of sand supply were insufficient for appreciable beach deposits or ridges develop over the shelf surface. The effect of the transgression is major transgressive or drowned coasts around world, perhaps best noted along the Atlantic coast and south America. This coast line extensive barrier-lagoon coasts, drowned estuaries and features created by rapid inundation.

Because the shallow water environments are in a state of disequiblibrium and because sediments are trapped in the

near shore areas most continental shelves are covered with relict sediments and are still dominated by morphology related to the quaternary low stands of sea level. Relict sediments are those that are related to past conditions even though they lie at the surface of the ocean floor.

THE NEARSHORE ZONE

Estuaries: An estuary has been defined as a semi enclosed coastal body of water freely connected to the ocean and within which sea water is measurably diluted with fresh water from the land. Estuaries are dominant features along many modern coastlines as a result of Holocene transgression. Present day estuaries are forming near tidal flats, barrier islands and river deltas.

Estuaries represent one of the most important modern geological features controlling the flow of terrigenous sediment from land to ocean. Most estuaries and associated coastal marshes represent sediment sinks or areas of entrapment.

Tidal processes are of the utmost importance in controlling estuarine sedimentary conditions.

Lagoons: Lagoons are highly variable, shallow marine environments separated from the open sea by barrier island complexes composed largely of well sorted sand. The barrier may be an island with dunes or no more than an offshore bar

transgressive coast lines in association with estauries. A typical estuary is a narrow elongate embayment while a typical lagoon is parallel to a sand barrier. As lagoons are filled with sediments they become tidal flats. Lagoonal sediments are generally fine grained since they are deposited largely from suspension. However, sands are also deposited as wash over fans and small scale deltas. Carbonate muds can be deposited where sedimentation is especially low, and evaporites may form in hyper saline lagoons.

Deltas :

term delta was first applied by Herodofus in the fifth century B.C. to the triangular shaped body of between the branching channels of Nile river. Because deltas form where rivers transport more sediment to the sea they can be redistributed by longshore currents, they produce a regressive shore line. Where longshore currents effectively this terrigenous material, bars and beaches redistribute parallel to coast line. The river flow maintains momentum to carry the sediment load upto several kilometers into the ocean as a jet before the current dissipates. jet looses the momentum most rapidly near its margins due stresses with the surrounding seawater. This leads sediment at the margins, forming submarine deposition of levees (Shallow embankments). Ridges may also form below the jet flow because of similar shear stresses developed along its lower surface.

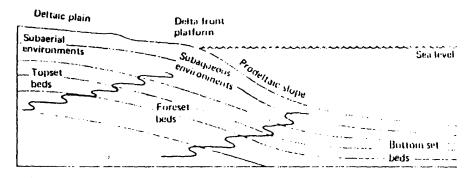
All deltas exhibit a system of branching "distributary channels" flanked by levees.

The top of delta consists of a radiating network of distributory channel sands flanked by levee sills. These radiating series of distributory sands are referred to as bar-finger sands.

Coarse sediment deposition in deltas is concentrated at the subaerial "delta front". Beyond this much finer sediments are deposited in the "prodelta" which is entirely below sea level.

As the deltaic system is prograded it gives rise to the classic cross section of topset, foreset and bottom set beds.

Topset beds : Topset beds are mixture of coarse sands deposited in the delta front and deltaic plain areas finer, organic rich sediments of the interdistributory areas. Forset beds are fine marine sediments of the prodelta facies. Bottomset beds are finer sediments deposited on the areas of deltaic complex and grading into sediments of the adjacent continental shelf. Fig. 1 describes the features more vividly about the delta morphology.

The most dynamic of all marine environments Beaches : located at the intersection of sea and land - beaches. Because beaches are constructed largely by wave processes, rates dependent upon are constantly changing at individual waves, different tides, different seasons different years. In strict sense a beach is an accumulation of unconsolidated sediment (sand, shringle, cobbles) low tide to a physiographic change such field. But a beach is considered by geologists to include the area below sealevel (to a depth of 10 to which is actively under the influence of surface waves.

When waves approach a shore line, the crests are bent to conform with the contours of the seafloor. This is called "wave refraction". The effect of this process is to distributed wave energy, focus energy on head lands, and reduce wave energy coves or embayments. At depths where the waves cannot complete their orbital motions, they increase in high and steepness and eventually begin to break creating the "breaker zone". The "surf zone" is a zone in which a shallow high velocity transition wave or "bore" is propelled up the beach face. This uprush of water produces sediment transport and sorting.

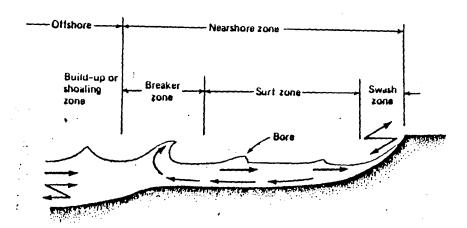


Figure .2. Terminology used to describe wave action in the nearshore regions. (From Paul D. Komar, Beach Processes and Sedimentation © 1976, pp. 12-13. Reprinted by permission of Prentice-Hall, Inc. Englewood Cliffs, New Jersey)

The "swash zone" represents the zone of maximum penetration of a shallow wave. Fig. 2 represents wave action in the near shore regions.

Beaches develop a profile that reflects the changing conditions. Four zones within the littoral or nearshore environments have been distinguished from landward to seaward. They are <u>back shore</u> -> Fore shore -> Inshore -> offshore.

The backshore is that part of the beach that is covered by water only during storms, and thus is above normal The backshore area consists of one or more gently sloping "berms" deposited by the receding waves. The limit of the berm is marked by an abrupt change in slope the "berm crest", or edge, which indicates the highest point normal wave activity. The beach face is a part "foreshore zone", although the foreshore zone may additional flat portions of the beach profile. "innershore zone" is the wider subtidal part of the profile extending to just beyond the breaker zone or the limit of the bar and trough topography. Terminology used to describe beach profile has been shown in figure 3.

Continental margin is the zone encompassing a wide that separates oceanic from continental transition zone realms and it includes continental shelf, slope and rise embraces the landward extension of the geological provinces. Mineral deposits that are found on the continental mainly classified into margins .are consolidated unconsolidated deposits which can be groped further on the of their genesis as terrigenous, biogenous Terrigenous mineral deposits are considered chemogenous. to be mainly derived from the land sources. Placer minerals the main constituents of the terrigenous group. The common placers are tin stone (cassiterite?), chromite, ilmenite, rutile, zircon, magnetite, monozite, kyanite, sillimenite, native metals like platinum, gold and gemstones like diamonds and garnets. These can be located either in the recent beaches and river beds or in the shelf as buried placers ancient beaches and river beds. Coral shells and calcareous biogenous products which can be commonly sands are the expected on the ocean beds. Barytes, phosphorites manganese nodules are considered to be chiefly chemogenous deposits.

Since the placer minerals have higher specific gravity, they are not transported over long distances and are always found in the river beds, beaches and nearshore areas like innershelf.

Terrigenous minerals deposited in the sea undergo further sorting and grading continuously through waves and currents. In addition to the above occurrences, pre existing coastline is yet another place to be considered on the innershelf for such minerals.

Placer can be defined as deposits alluvial and colluvial material which contain economic quantities of some minerals such as gold, platinum, tin, diamonds, zircon, rutile, monozite, ilmenite etc. Chemically minerals are not decomposed by weathering processes. As surrounding rocks are dissolved and disintegrated, stable minerals remain unaffected and are carried away rain, streams waves or wind. The lighter particles are and dispersed, but heavy stable minerals either remain particles in the soil or got transported as and gravel by streams. Further agitation within the stream or beach environment will cause the heavy particles to settle to the bottom and continuously enrich the deposits by removing the lighter and more brittle gangue. The net effect concentration of heavy, chemically stable minerals. concentrations are called placers.

Heavy mineral sands popularly called black sands occur between Quilon and Cape Comorin in Kerala, Tinnavelli, Ramnad and Tanjore districts of Tamil Nadu, Visakhapatnam and Bhimunipatnam beaches of Andhra Pradesh and some coastal areas of Orissa state. The occurrence of ilmenite on the

beaches of Ratnagiri (Konkan coast) was documented in 1945 by M.S. Krishnan.

The National Institute of Oceanography, undertook exploration programme along the Konkan coast and reported the presence of large deposits of ilmenite and magnetite along the beaches of Konkan. The work extended over a stretch of 130 km covering nearly 13 bays, Jaigad in to Vijaydurg in south. Preliminary results of investigations have proved to be very encouraging mineable deposits have been found in good number. Detailed multi sensor geophysical investigations carried out for first time on the west coast have been summarized down below:

Layout of the cruise tracks

Since the onshore structures and geology are supposed to be extending laterally towards offshore, the cruise tracks are planned nearly perpendicular to the main landmass. The profiles (east-west) were planned in such a way that wherever the beaches are exposed, the track spacing was kept at 200-250 m. The spacing between two tracks was increased (400-800 m) wherever promontories are exposed. Criterion for this sort of track spacing is that the surface sampling clearly indicated soft clays distributed off promontories where sands are totally absent or a very thin layer of sand underlie the clays.

Geological Framework: The Konkan coast comprised of 13 bays forms the coastal stretch of Maharashtra state. The

geological formations of Maharashtra state include those Paleozoic, Tertiary and Quaternary periods. Pre-Cambrian, the state is covered with a thick pile of Deccan Most basalt flows. The coastal regions are characterised laterite formations. Hills, valleys and scarps characterize coastal stretch. The cliffs of the hills are extending into the sea as in Jaigad and Warori bluff. Basalts are found to occupy the lower levels and are topped by laterites. Fresh exposures of basalts are seen below the scarps. The Trap basalts which are extensively spread over the central Indian plateau along with dikes and sills belong to Cretaceous to lower Eccene age. Boulders and pebble quartzites with minor conglomerate shales and lime stones Kaladgi formations and newer laterites, uralitised dolerites, schists and gneisses of Dharwar group and conglomerates, granulitic gneisses, quartzites, mica schists, amphibolites etc. of Archaean age are classified under Cambrian group.

The most conspicuous structural deformations documented over the trap covered areas are fractures, dykes, alignment of hot springs and earthquakes. Fractures extending several kilometers in length are recognized all along the mainland. Most of these features trend NW-SE, NNW-SSE, N-S. However, the fractures between the Narmada-Son lineament and the west coast show a prominent ENE-WSW trend with NNW-SSE and WNW-ESE orientations. Majority of the dykes trend NNW-SSE, N-S, NE-SW and NNE-SSW directions.

Qualitative interpretation

field : A total 1. Magnetic intensity earth's magnetic anomaly contour map in general depicts the spatial variation of total magnetic intensity of the geomagnetic field together with that of anomalous magnetic field caused by the changes in the magnetization of the crustal rocks down to the isotherm. The magnetic map also provides evidence spatial distribution of magnetic susceptibility intensity of magnetization of the underlying rocks which turn depends on the distribution οf magnetic minerals either because of their large magnetic susceptibility because of their ability to hold a fair amount of remanant magnetization. Among the naturally occurring magnetic minerals. magnetite is the most abundant. Geological involved in the formation of various processes igneous and sedimentary rocks and the subsequent metamorphism undergone by them under vastly different physico-chemical conditions alter, destroy, generate and redistribute the magnetite in the rocks. They in turn impart a pattern to the magnetic map. Interpretation of magnetic map is therefore attempt to understand this inherent pattern and related same to the underlying geology. Qualitative interpretation is essentially an exercise in pattern recognition. The is characterised by N-S, NW-SE and WNW-ESE magnetic lineaments of these, NW-SE and near N-S trends predominate and they persist for considerable lengths. The small anomaly closures confine themselves to few traverses only.

The trend of the magnetic anomalies recognised in the northern part of the map are indicative of dislocations and block movements along NW-SE/WNW-ESE oriented weak planes. The N-S, NW-SE, WNW-ESE and NNW-SSE magnetic anomaly trends are probably fractures fissure zones, faulting and dislocations though which magnatic material might have been emplaced and latter altered by perlocating waters and other processes.

Thus, the magnetic anomalies may be viewed as due to the structural disturbances in the Deccan Trap basement and its weathered derivatives in the form of dislocations and shear zones besides other topographic irregularities affected by erosion and cut and fill type paleochannels and other type of favourable ground for the accumulation of placer deposits.

Seabed topography and sediment distribution

We made use of the echograms for not only the preparation of bathymetric map (Fig. 5) but also to identify the nature

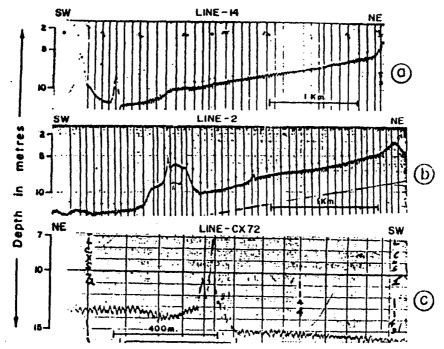


Fig. 3 Echograms showing (a,b) steep seafloor near Binge shore, (NE) and (c) rugged topography SE of Anjadip Is.

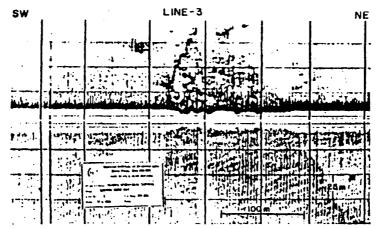


Fig. 5 Sonograph showing surface expression of submarine ridge 0-8 km. NE of Round 1s.

of the sediment cover and rock out crops on the seabed. The seabed topography is even and gentle over large area except near promontories. The seabed is largely covered by sands, silty sand, sandy silt and clay. The echograms (Fig. 6) depicted opaque and transparent sediment patterns for sand and clay respectively. Sand cover the seabed upto the water depths of 9-12 m and beyond this depth clay overlies the sands and the thickness of clays increases offshore.

Cores collected from the seabed distinctly showed the clay sand contact. The top 40cm of the cores consists of reddish brown clay below which is seen live grey clay which inturn overlie heavy mineral rich sands. It was also found from the grain size distribution studies that the sediments are mostly well sorted and unimodel whereas the sediments at river mouths are poorly sorted and polymodel representing a mixed depositional environment.

Shallow seismic studies: The character of seismic records, penetration depth and strength of the bottom reflections, adequate subsurface information. provide The seismic sections (Fig. 7) show three to four well defined stratal surfaces characterised by high amplitude and continuous reflections the bottom most reflector is recognised acoustic basement, mainly representlin the seaward extension οf Deccan Traps locally representing the weathered/altered trap or a reworked surface. With the of borehole data available in the vicinity of the study area, it has been identified that bottom most reflector represents

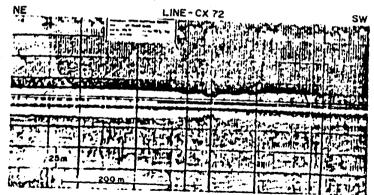
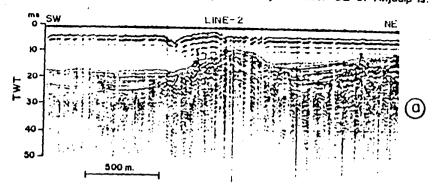


Fig.4b Sonograph showing irregular rocky seafloor SE of Anjadip Is.



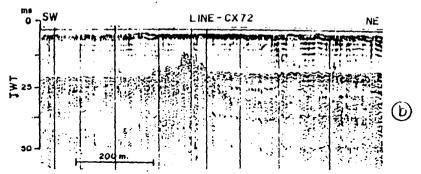


Fig. 7 Sparker records showing the surface expression of (a) Round is, and (b) rock outcrop SE of Anjodip is.

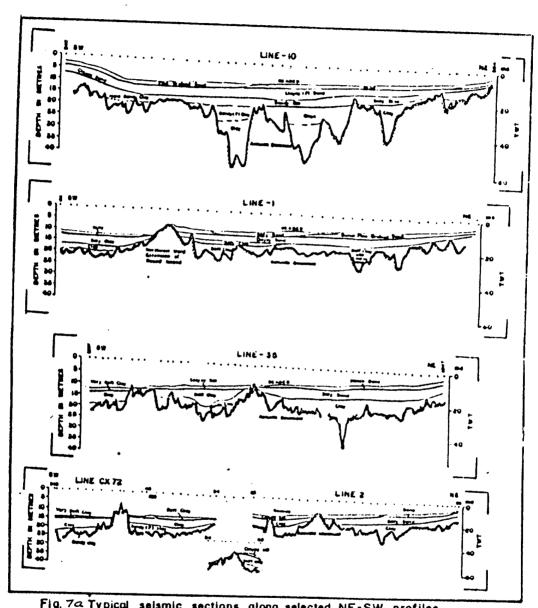


Fig. 7a Typical selsmic sections along selected NE-SW profiles showing 3-4 prominent reflectors and basement.

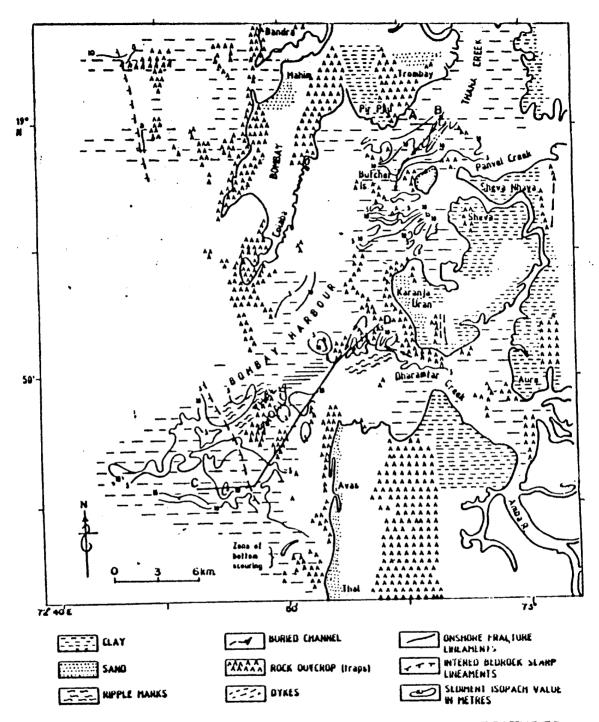
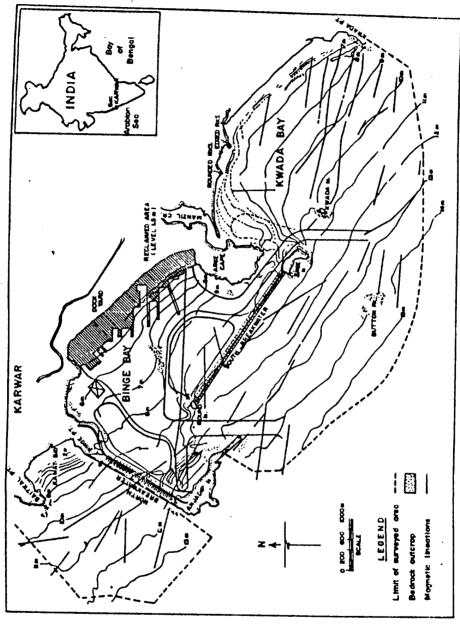

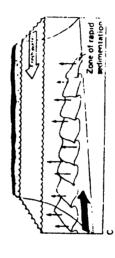
Map showing the geophysical survey coverage off Karwar. Bathymetric, side-san sonar and mognetic survey results are also depicted. 9

either top of the Deccan Trap or its weathered derivative. The reflector immediately above this acoustic basement comprised of boulders, sand and silts. The top layers comprised of sand (in the nearshore area, 9-12m) and beyond this depth they are either clay/silty clay. It was established that the sand and clay contact zone occurs at 9-12m water depths.

To sum up, the marine geophysical studies helped in delineating the horizontal as well as vertical distribution of heavy mineral placers in the nearshore areas. These placer sands deposits are recognised by their high frequency short wavelengths with 120-200nT amplitudes. Magnetic model studies suggest that the thickness range from 10-20m with varied concentrations of magnetites and ilmenites.

Using the geophysical methods the subsurface geology of Bombay harbour, Konkan offshore and off Karwar have been inferred to a fair degree of accuracy which are confirmed by the lithological data of bore holes.

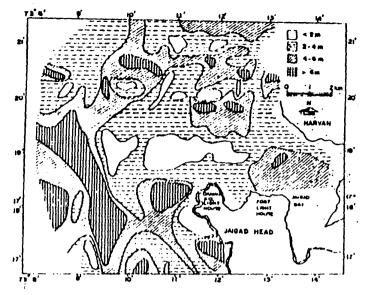


Fig.8. Isopach map of heavy mineral rich sands (After Rajamanickam et al. 1988)

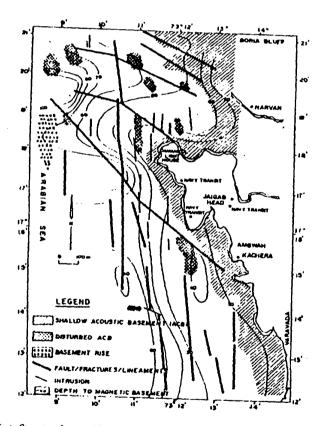
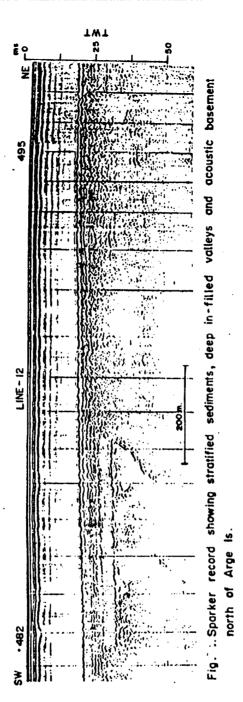


Fig.' . Structural map of Jaigad, Ambwah and Varavada bays and the depth to the magnetic basement.
