

inst temperature. From the slope of the curves it is evident that effect of temperature on the viscosity of LNR is very sigant. In the lower temperature range of 20°C to 80°C slope is te, indicative of a larger reduction in viscosity. The sample with highest initial viscosity developed comparatively less fluidity at 140oC than the low molecular weight samples. For low molecular weight LNR, a 30 fold reduction in viscosity was noticed when temperature increased from 20oC to 80oC Whereas it was only a six fold reduction when the temperature rose from 60 to 140oC. In the case of the sample with the highest viscosity corresponding values were 22 and 10 respectively.

## 4. Conclusion

The present investigations indicated that liquid rubber samples of Brookfield viscosity less than 1,00,000 cps showed Newtonian tendency while higher viscosity samples showed pseudoplastic behaviour. Reduction in viscosity due to increase in temperature is faster at low temperatures and slower at high temperatures.

SPENDED SEDIMENT TRANSPORT AND SHOALING IN THE MUNAMBAM FISHERY HARBOUR, KERALA

Abstract: Results of the Monthly synoptic field observations of vertical profiles of suspended sediment concentration, current velocity and salinity carried out in the Azhicode estuary are presented with a view to understand the shoaling and siltation phenomena in the harbour region. Based on various physical and geomorphological data available on the harbour and near shore region, remedial measures are suggested to prevent the siltation and shoaling at the entrance channel and the sandbar formation at the harbourmouth. This paper also highlights various aspects of hydrodynamics in the lower reaches of the estuary.

#### htroduction

The Azhicode estuary is formed by the major arm of the ivar river which joins the Arabian Sea at Munambam. The lakkudy river joins the estuary about 10 km upstream from the uth. Compared to Cochin estuary, Azhicode estuary is shaler, the maximum depth at the entrance channel being about 8. The width of the estuary near the barmouth is 750 m and at inlet entrance, about 250 m. The average depth of the study a is about 3.5 m (Abraham Pylee 1987). Sedimentation in the

harbour region as well as the sand-bar formation across the entrance channel is a major menace to the safe entry and berthing of the fishing boats.

# 2. Materials and Methods

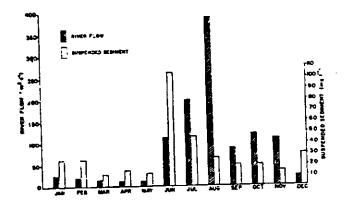


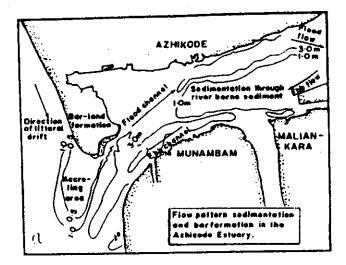
Fig 1. Monthly observation of river flow (Solid Bars) and suspended sediment concentration (Open Bar)

Study are and station location area shown in Fig 1. Monthly synoptic field observation of vertical profiles of velocity, temperature, salinity and suspended sediment concentration for one tidal cycle were carried out at all stations for a period of one year.

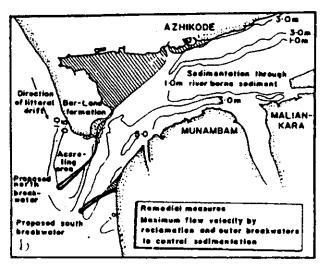
Current speed and direction measurements were made by rotor current meters. Measurements of vertical profiles of salinity and temperature were accomplished by Beckman electrodeless induction salinometer. Suspended sediment concentration at surface, mid depth and near bottom were determined by vaccum filtration of water samples through pre- weighed 0.45  $\mu$ m millipore filter paper (Cremton and Beckley 1972). Cubic splines were used to interpolate the data at fixed fraction of the non-dimensional depth ( $\eta = 0$  and  $\eta = 1$  at surface and bottom respectively). Procedure for computing tide averages and depth averages as given by Kjerfve (1979) were followed.

## 3. Results and Discussion

Total river discharge into the estuary varied from 14 m<sup>3</sup>.s<sup>-1</sup> during May to 400 m<sup>3</sup>.s<sup>-1</sup> during August. Tides in the Azhicode estuary were semidiurnal, with maximum amplitude of 1 m and minimum amplitude 60 cm during spring and neap respectively. Fresh water input into the estuary during this period was 14 m<sup>3</sup> S<sup>-1</sup> and the maximum diurnal amplitude of tide is 0.69 m. During this period tide was the principal factor which controlled the transport processes and the distribution of salinity and currents in the estuarine system. During ebb tide it was observed that high saline water penetrates well beyond Chennamangalam (12 km upstrem). Longitudinal gradient in salinity between Azhicode and Chennamangalam was 9 X 10<sup>-3</sup> at the surface. Increased influence of tide was very much manifested in the distribution, well mixed zone extended further landward and reached upto Gothuruth as implied by the orientation of 35 X 10<sup>-3</sup> isohaline. Axial and vertical gradients were weakened and the the estuary become moderate to well mixed state.

Influence of increased river flow (400 m $^3$ s $^{-1}$ ) was reflected on the salinity distribution pattern during August. Initial response of the river flow rapid reduction in bottom salinity and a reduction in stratification, which implied that the increase in adverse barotropic pressure gradient was sufficient for a short period to prevent strong penetration of salinity into the upper estuary. Salinity plots are presented only for flood tide. Salinity was < 1 X  $10^{-3}$  during ebb-tide in the entire estuary. It was observed that inspite of the increased river discharge vertical homogeneity is maintained in the lower 5 km reaches of the estuary as indicated by 32 X  $10^{-3}$  isobaline. Further upstream vertical and axial salinity





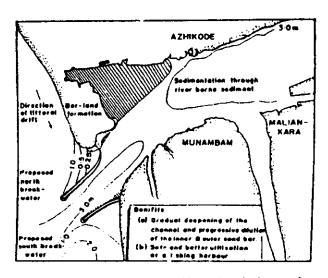


Fig 2. Siltation and shoaling at Munambam harbour and suggested preventive measures.

dient increased and reached as high as  $28 \times 10^{-3}$  between whereth and Chennamangalam.

During the pre-monsoon period vertical gradient remained  $(1 \text{ to } 2 \text{ X } 10^{-3})$  at sections I & 2 and high  $(17.5 \text{ X } 10^{-3})$  at tion-3, which showed stratification was more towards the head like estuary compared to bar-mouth, where as during the monom period stratification was higher at the lower section, with shwater at station-3, salinity gradient of  $5 \text{ X } 10^{-3}$  at section -2 49.5 X  $10^{-3}$  at section-1. Thus it could be seen that density edient circulation was limited to barmouth region during monom.

The culcrian residual current registered a net seaward flow sughout the year. Vertical gradient was negligible during pressoon season at section -1 & 2, where as at section-3 velocity shigher from  $\eta = 0$  to  $\eta = 0.3$ . This showed that circulation ring pre-monsoon was controlled by tide rather than the shets. Residual flow was directed downstream throughout the tercolumn during August, with comparatively higher velocity in those during March. At all the sections residual current reased from surface to bottom. Lower values of residual curlat section-2 compared to other section could be attributed to thopography of the region.

# imentation and sandbar formation in the Munambam

Sandbar was noticed at Munambam early in the seventies. esand carried by the Periyar was deposited on both sides of the d and reducing the outlet to a small and shifting channel of flow depth. A portion of this large antity of riverborne sediment is getting deposited in the harbour ion, due to the rapid reduction of flow velocity as the water sout in the shallow mud flat area (Fig-2a), resulting in the paling of the entrance channel and the adjacent region. To assess the processes behind the formation of sandbar across the entrance channel, some discussion of the waves, littoral and associated transports in the adjacent coastal area are of some value and data presented here are for a station 10 km north of Azhicode. This data holds good for Azhicode as the meteorological and coastal features are almost same for both the locations. Maximum wave height of 1.5 m is observed during June and minimum wave height of 0.45 m is observed during October. Wave period varies from 6 seconds during June to 11 seconds in the month of October. Littoral current is directed southward during June- September with speed in the range of 20-30 cm.s<sup>-1</sup> Weak northerly current was observed during October-February. Annual net littoral drift was southward and was estimated to be 6  $\times$  10<sup>4</sup> m<sup>3</sup>, of this 2.5  $\times$  10<sup>4</sup> m<sup>3</sup> was during June alone (Sajcev, unpublished). Sudden increase in the vertical and horizontal extenting of the sand bar during monsoor can be explained in the light of the large volume of littoral transport. Thus it is to be believed that the southerly littoral drift and the westerly winds are the major factors for the formation of sandbar. Part of the river borne sediment also may contribute its share to the formation of sandbar, but the extent of which has to be investigated further.

Based on the data collected, and the information available from various sources and also from the experience gained during the study of similar estuaries, we suggest that if the sand bar is dredged out and the dredged material is used to reclaim the shallow mud flat area (Shaded portion in Fig.2), it is possible to channelise the flow and thus attain the flow velocity sufficient to flush sediments out of the harbour region and thereby prevent shoaling. Construction of offshore structure either in the form of breakwater or groynes as shown in the figure, will prevent southerly and northerly littoral sediment transport and thereby the sandbar formation. Orientation, nature and length of the structure can be decided only after physical modeling. Fig.5c is a conceptual picture showing the benefits such as gradual deeping of the channel and progressive dissipation of the sand bar obtained on the implimentation of the preventive measures suggested.
