Polycyclic Aromatic Hydrocarbons (PAHs) and n-alkanes in Beaked Sea Snake *Enhydrina schistose* (Daudin, 1803) from the Mandovi estuary, Goa

Abstract

An ecotoxicological study were conducted to evaluate the concentrations of PAHs and n-alkanes, in gut, liver and kidney tissues of two individuals of *Enhydrina schistose* (Daudin, 1803), using gas chromatography/mass spectrometry (GC/MS). The concentrations of PAHs (0.10 μ g/g) and n-alkanes (8.12 μ g/g) were elevated in the gut, and liver (PAHs 0.05 μ g/g tissue, n-alkanes 29.16 μ g/g tissue). In kidney of both specimen-A and B the PAHs (0.01 and 0.1 μ g/g) and n-alkanes (0.22 and 2.06 μ g/g) concentration was detected. This was an initial survey (n=2) and the main goal was to know accumulation and distribution of PAHs and n-alkanes in the sea snakes. This study indicates high accumulation of petroleum hydrocarbon in gut, liver and kidney of sea snake. Since, this species also act as pray for sea eagles and some predatory fishes such as tiger shark, there is high possibilities of PAHs being circulated in marine food chain.

Introduction

As environmental contaminants have been implicated as a possible cause of some declines of herpetofauna, there has been a substantial increase in the amount of reptile ecotoxicology research conducted over the last decade. In general, previous reptile studies have focused on measuring the body burdens of various pollutants from samples collected in the field (Meyers-Schöne 2000). While these data are useful for understanding the historical exposures of given populations, the actual risks and population level effects of pollutants on reptiles is still largely unknown and generally understudied. According to eminent eco-toxicologist "Hopkins", reptiles are the least studied group of vertebrates compared to birds, mammals, fish and amphibians (Hopkins *et al.* 2001).

Snakes can be the ideal candidate species in monitoring the various contaminants in the wild life, because all the snakes are carnivores and known to accumulate environmental contaminants like chlorinated hydrocarbons (Fleet et al. 1972), polychlorinated biphenyls (Bishop et al. 2000), polychlorinated dioxin (Sabourin et al. 1984) and metals (Hopkins et al. 1999; Mohsen Razieie 2011) primarily accumulated from their prey items. The lethal effects of PHC (petroleum hydrocarbon) spills have been more frequently investigated, even phytoplankton and algal-derived hydrocarbons alter the endocrine and reproductive function in invertebrates and fish (Collier et al. 1986; Oberdo et al. 1999, 2000). However relatively little data is available on effect of PHC exposure in sea snakes. Worldwide decline of sea snake population has been causing a great concern in the scientific community (Gibbons et al. 2000). PHC can be used as valuable tool for tracing the eventual fate of oil in marine ecosystem; however, analysis of the total petroleum hydrocarbon (TPH) content is not sufficient to understand exposure of oil spill on marine organisms. A more extensive characterization and a separation of the complex hydrocarbon mixture into individual components is necessary for distinguishing between hydrocarbons of recent biogenic origin and hydrocarbons from fossil fuels. Among the most ubiquitous PHC in estuarine environment, polyaromatic hydrocarbons (PAHs) have become increasingly important because of their potential carcinogenicity, mutagenicity and teratogenecity to aquatic organism (Dhanajayan et al. 2012). When an organism is exposed to the PHC, owing to their lipophilic nature, it can easily penetrate biological membrane (Tuvikine 1995; Hamlink et al. 1977) and accumulate in the organisms. However, the concentration of these compounds in the tissues of candidate species under evaluation varies until it reaches a steady state level (Naser et al. 1992). In fact, tissues of biological organisms are frequently analyzed to describe the route of hydrocarbon uptake and biotransformation (Jeffery et al. 1999).

Liver and kidney are main organs of storage and excretion of PHC and its metabolism involves number of reaction, that convert lipid soluble (non-polar) organic compound (e.g. PAHs) to more water soluble to make them easy for excretion. These transformation processes are enzymatic and usually classified in to two types: phase-I and phase-II (Jimenez *et al.* 1990). Phase-I reaction involves enzymes (cytochrome 450 monoxygenase system) which introduce polar group in to xenobiotic molecule through oxidative, reductive and hydrolytic processes (Tuvikene 1995). The phase-II reaction involves conjunction to other molecules or their phase-I metabolites with polar endogenous constituent such as glucoronic acid, sulphate, amino acid or glutathione (Lech *et al.* 1985).

There are many studies that document the detection of petroleum hydrocarbons in the marine environment (Goa coastal water (Fondekar *et al.* 1980), north-west coastal water (Kadam *et al.* 1993), fish and prawn (Mehta *et al.* 1994; Dhanajayan *et al.* 2012; Ansari *et al.* 2012), bivalve in east coast (Mohan and Prakash *et al.* 1998), fresh water and fish (Malik *et al.* 2008), sediment (Ingole *et al.* 1989, 2006; Harji *et al.* 2008), and marine environment of Mumbai (Chouksey *et al.* 2004)). However, there is no information available on evaluation of n-alkanes and PAHs in sea snakes. *E. schistose* lives in the in near shore shallow waters and estuaries, especially in the soft bottom marine environments, where its preferred prey, catfish, occur in high abundances (Voris H K 1985; Aaron Lobo *et al.* 2004)

Present study demonstrates the tissue specific distribution of 15 EPA priority PAHs and 27 n-alkanes compounds in two individuals of *E. schistose*. We used GC-MS for analysis, which is the standard analytical technique for oil chemical fingerprinting, because it can resolve a broad range of petroleum biomarkers and polycyclic aromatic hydrocarbons (PAHs).

Materials and Methods

Two individuals of *E. schistose* were collected from the intertidal region of Caranzalem beach, Mandovi estuarine of Goa. The specimens were partly injured as they were entangled in the shore fishing net "*Rampanni*". The first individual specimen was collected on 15th September 2012 and marked as Specimen A, while second specimen was collected on 27th November 2012 and marked as specimen B. Both specimens were immediately transported to the laboratory from the collection site. The morphological characteristics were noted and specimens were stored at -20°C until further analysis. Snake samples were taken out from the deep freezer, thawed and dissection was performed on ice cold condition, using solvent rinsed instruments and glass dishes. Tissues (gut, liver and kidney) were separated and dissolved in 20 ml dichloromethane/hexane (1:3 v/v) with surrogate internal standard (SIS) 20 ppm-200µl Tetracosane-d₅₀ for alkane, 5ppm-200µl Chrysene-d₁₂ for PAHs were spiked and transferred to 5% H_2O deactivated silica gel column (1 cm i.dx 9 cm). Elution was performed using 20 ml of dichloromethane/hexane (1:3 v/v) to get the solution containing alkanes and PAH's. The resultant solution was concentrated to 1-2 ml using rotary evaporator. This has been fractionated using fully activated silica gel column chromatography (0.45 cm i.d. x 18 cm) called the second step column chromatography to separate alkenes and PAHs. The extract was then rinsed with 8 ml (the first of 2 ml: 0.4 ml, 0.3 ml, 0.3 ml, 0.5 ml, 0.5 ml, respectively and 6 ml of distilled hexane) and the eluent was collected in pear shaped flask (1). Then, the column was eluted with 14 ml of dichloromethane/hexane (1:3 v/v) and the eluent was collected in another pear shaped flask (2). Both the eluent in the pear shaped flasks (1) and (2) were concentrated to a few milliliters using rotary evaporator followed by gentle nitrogen blow down to remove interfering of H_2 and CO_2 . These two fractions were evaporated to dryness under the nitrogen blow down and rinsed with calculated amount of DCM and transferred to suitable glass vial for further GC-MS analysis. One solvent method blank and one SIS blank were processed together for each batch of samples. The concentration SIS from each analysis was used to estimate and check the recovery. The recovery of SIS ranged from 60% to 120%. Correction factor for recovery were not applied while estimating concentration of analyte. However, samples were taken up for repeat analysis, where recovery estimated is less than 90% or more than 105%.

GC-MS of the samples were performed using a Shimadzu QP-2010 gas chromatograph interfaced with GCMS-QP2010 mass spectrometer. The gas chromatograph was equipped with a 20 m length. 0.1 mm i.d. 0.1 μ m film thickness Rtx-5 MS capillary column coated with 5% phenyl 95% methyl siloxane. The GC conditions were; oven temperature hold at 70°C for 1 minute, rise to 140°C at rate of 10°C minutes-hold 0, then rise to at 300°C at rate 6°C hold 30 minutes. Other settings of GC/MS; interface & injection temperature as 300°C, ultra-pure 'He' as carrier gas with a flow rate of 0.5 ml min⁻¹, split less injection mode, scan range of 40-650 amu, and electron ionization mode with 70 eV. Quantification and identification of individual hydrocarbon compounds were achieved using standard method of external reference standard technique. Detection of hopanes and steranes was done using ions at m/z 191 and m/z 217, respectively (Zaghden *et al.* 2005; Harji *et al.* 2008). Reproducibility of the whole analytical procedure was checked through ten numbers of anlysis of 5ppm alkanes, hopanes and PAHs mix standards. Relative standard deviation of the individual alkanes, hopanes and PAHs standard concentration were less than 10%, 15% and 5% respectively.

Results

The concentration of PAHs among the different organ tissues of the two individuals of *E. schistose* (Daudin, 1803) are listed in table 1 and fig. 2. The total PAH in the gut region was found to be higher as compared to liver tissues of both the specimen. The kidney of the both specimen detected trace concentration of PAHs, the total PAHs of kidney tissue was compared with specimen-B, it was found to be higher by 33.3% than specimen-A. Acenaphthene ($C_{12}H_{10}$) and benzo(a)anthracene ($C_{18}H_{12}$) were detected in liver and gut tissues of Specimen-A and only acenaphthylene ($C_{12}H_8$) was detected in gut of specimen-B. Out of 15 PAHs compound, 12 were detected in liver tissue of specimen-A. Whereas only 3 compounds (Naphthalene, phenanthrene and dibenz(a,h)anthracene) were detected in liver of specimen-B. Naphthalene and anthracene were detected in kidney tissues of both the specimens (Table 1). Out of 15 PAHs, the predominant PAH in the gut was found to be Pyrene (56.56%) and naphthalene (84.57%) was found to be the predominant in liver tissue.

The concentration of n-alkanes among the different organ tissues of two individuals of *E. schistose* are listed in table 2. However the concentration of n-alkanes in liver tissue of specimen-A was higher compared to specimen-B (Fig.3). The kidney of specimen-B suggest the higher concentration of total n-alkanes than the kidney of specimen-A. The total 27 n-alkanes compounds were analyzed, kidney of specimen-A detected C_{14} , C_{15} , C_{16} , C_{17} , C_{19} and C_{28} while the kidney of specimen-B detected C_{14} , C_{16} , C_{17} , C_{19} to C_{33} and C_{37} which is found in gut and liver tissues of specimen-A. However it is absent in Specimen-B. Out of all the 27 n-alkanes compounds, n-Heptacosane (C_{27}) was found to be predominant in the gut and liver.

Discussion

Being carnivores, reptiles can easily magnify the contaminant through food chains as they have high food conversion efficiencies and can convert substantial amount of ingested energy into biomass (Hopkins 1999). As the gut content of both the sea snake specimen has high concentration of PAHs, therefore the snake specimens investigated here must have consumed contaminated prey items which led to the increased accumulation of hydrocarbons.

As shown in table 2, the distribution of short chain n-alkanes (C_{13} to C_{22}) demonstrated the predominance of even carbon n-alkanes C_{14} , C_{16} , C_{18} and C_{20} . The predominance of these short chain even *n*-alkanes indicates the contribution of marine microorganisms and petroleum products (Grimalt *et al.* 1987; Garg *et al.* 2004 and Harji *et al.* 2008). Pristane and phytane are isoprenoid hydrocarbons originating from geologic alteration of phytol and other isoprenoidyl products and are not primary

constituents of most terrestrial biota (Peters *et al.* 1993; Gao *et al.* 2007). They are usually present in most petroleum as major constituents and are considered as good indicators of petroleum contamination (Volkman *et al.* 1986; Readman *et al.* 2002; Zaghden *et al.* 2005). The presence of trace petroleum biomarkers viz., hopanes and steranes (results not shown) in alkane fraction authenticate hydrocarbon found in the tissue of sea snakes is most likely from petroleum source.

Elevated levels of PHC was observed in gut>liver> kidney, it might be due to the fact that virtually all xenobiotic substances are absorbed from the gastrointestinal tract which passes through the liver before entering the central circulation via hepatic portal circulation (Vanddenberghe 1996). Tissue specific distribution of PAHs and n-alkanes are not well known in sea snake but the studies on biotransformation mechanisms in other marine organism suggest that biotransforming enzymes are widely distributed throughout the body and liver is the primary biotransforming organ. Thus the total PAHs (Fig.2) and total n-alkanes (Fig.3) have been detected in significant concentration in liver tissues of both the specimens, which may be due to lipophilic nature of PHC and will be stored for varying times in the tissues with higher concentration in liver. The result shows that concentration of n-alkanes was appreciably high in specimen-B (29.164 μ g/g of wet tissue) liver tissue as compared to Specimen-A (6.055 μ g/g of wet tissue) liver tissue. This was perhaps due to the digestion and metabolic activities of snake, as gut region of specimen-B had fully digested prey whereas, gut of specimen-A had undigested prey (catfish sp.?) as shown in fig.4. The metabolism of PHC involves number of reaction that convert lipophilic organic compound PAHs to water soluble substance which facilitate easy excretion. Kidney has been studied in the various reptilian groups as target organ for xenobiotics, especially in turtle and crocodilians (McClellan-Gren et al. 2006). In the present study, out of 15 PAHs compounds only naphthalene and anthracene were detected in kidney tissues of both specimens. The petroleum hydrocarbon is absorbed in the body via diverse routes and removed immediately by the liver through the first-pass metabolism. When the quantity of hydrocarbon ingested exceeds the capacity of the liver to metabolize, it is absorbed in the blood at gastrointestinal tract and finally reaches kidney (Janssen et al. 1988). According to Nagelkerke (1996), toxic substances are mixed in the blood and passes through kidney thus reducing their concentration in body tissue. However, there is a paucity of literature on the toxic impacts of oil contamination in sea snakes and further study is required for underline the reasoning for significant accumulation of PAHs and n-alkenes in various tissues. Although the results described in this study shows elevated PAHs and n-alkanes in different organs of sea snake, it need to be treated with prudence.

Conclusion

Even though, no major accidental oil spill is reported in last two years in and around mouth of Mandovi river of Goa, daily routine activities like casino's, ferry boat, larger number of fishing trawlers, ore carriers are moving in the river. Moreover, tar balls are occurring frequently along the Goa coast and all these above activities are responsible for increased level of oil contamination in the estuarine environment. Our study suggested elevated accumulation of PHC in the gut, liver and kidney of two individual sea snakes (n=2). Thus, sea snake being a carnivorous, and act as prey for sea eagles and some predatory fishes such as tiger shark, there is higher possibility of PAHs being circulated in the marine food chain. However, further study is needed to understand the mechanism of detoxification of petroleum hydrocarbon in sea snakes and also to take requisite action in order to control the anthropogenic activities that are responsible for PHC contamination in the coastal environment.
