TIDES AND TIDAL HARMONICS AT UMBHARAT, GUJARAT

ABSTRACT

A part of the data on tides recorded at Machiwada near Umbharat, Gulf of Cambay during April 1978 was subjected to harmonic analysis following the Admiralty procedure. The general tidal characteristics and the value of four major harmonic constituents are reported.

At the instance of the Oil and Natural Gas Commission (ONGC), a comprehensive study of the nearshore waters at various land approaches of the proposed submarine pipeline between Tarapur and Hajira was conducted for over a year from January, 1978 (Anon. 1979). Tide was one of the parameters studied in detail and the present paper deals with the description of the tides and their harmonics at Umbharat (Gujarat) during this period.

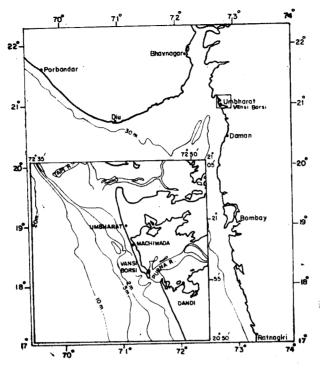


Fig. 1. Location Map.

Umbharat is situated close to the river Purna (Fig. 1). Some physical characteristics of the coastal waters of this region have been described earlier (Swamy, Sarma & Suryanarayana, 1982). The study area is under the influence of semi-diurnal tides with significant diurnal inequality. The range of the tides is large and particularly so in the northern parts of the coastline. The tidal streams generally set northward during the flood, and southward during the ebb of the tidal cycle.

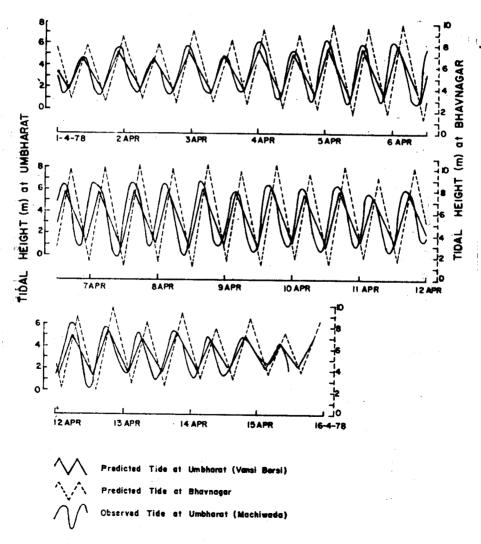


Fig. 2. Tides at Umbharat.

The water level variations were obtained by visual observations using graduated poles erected across the beach within the intertidal zone at Machiwada (Umbharat) (Fig. 1). The intertidal area was extensively muddy and had a width of about 0.5 km at this station. This caused many operational problems. The zeros of the poles were inter-related and were again related to the bench mark nearby, by levelling and theodolite surveying. Ultimately the observed water levels were reduced to the Chart Datum. The observed tide data were plotted (Fig. 2) along with the predicted tides (only high and low) at Vansi Borsi (near Umbharat) (ONGC, personal communication) and at Bhavnagar (nearest standard tidal station) (Anon. 1977). The general characteristics of tides in this area were thus obtained (Table I).

The tides at Machiwada lead over the tides at Bhavnagar by nearly 2 hr. 30 min. However it may be noted that at Vansi Borsi, which is situated at the mouth of Purna river, the tides lag behind the Machiwada tides, particularly the low tide (Table I). With reference to the tides at Bhavnagar, the tidal range at Machiwada was smaller by a factor of 0.63 as observed.

A part of the observed tidal data viz., the data on water level variations for the period 1–16 April, 1978 was subjected to harmonic analysis following the Admiralty method (Anon. 1964). This method has found wide application and it was chosen here owing mainly to its simplicity and immediate applicability. The theory of the semi-graphic method of tidal analysis has been detailed in Admiralty Handbook (Anon. 1959) and by Dronkers (1964).

The most important constituents analysed for, were M_2 , S_2 , K_1 and O_1 , where M_2 and S_2 are in the semi-diurnal species and K_1 and O_1 are in the diurnal species, as per the conventional notations (Anon. 1959).

Any particular constituent of the actual tide as produced in the ocean usually lags behind the constituent of the corresponding tide-raising force. A further lag is introduced in the response of the water at a particular place, to the tide-raising force constituent which produces it. The lag of the tidal constituent at a given place, behind the corresponding tide-raising force constituent at Greenwich is a constant for the place and constituent and is denoted by g, measured in degrees. Hence, the phase of a tidal constituent at a particular place is the phase of the corresponding tide-raising force constituent at Greenwich, minus g. The lag g is a constant angle for a given place and constituent. The amplitude of a particular tidal constituent on a

date when its nodal correction factor (f) (Anon. 1959) is unity is a constant for the constituent at that place. It is denoted by H. The amplitude of the same constituent on any other date at the same place will be fH.

These two quantities H and g for every constituent collectively form the harmonic tidal constants for the place. The height of tide at the place can be found as the sum of the values of fH cosine (E+u-g) of each constituent. Here E is the phase of a constituent of the tide-raising force at Greenwich in combination with u which is the phase correction (Anon. 1959). The variations of f and (E+u) are precisely known (Anon. 1978).

The harmonic constants of the four major constituents of the tide at Machiwada (Umbharat) determined for each day are given in Table II. For the calculation of the harmonic constants, the angles and factors of the tides for each day were taken from Admiralty (Anon. 1978). The nearest standard port considered was Bhavnagar for the purpose of the calculation.

With the determination of these main constituents, approximate tidal predictions can be made for many practical purposes in this area.
