# Little Genetic Variation in the Oil Sardine, Sardinella longiceps Val., from the Western Coast of India

#### Abstract

Enzyme gene variability in the oil sardine, Sardinella longiceps, from three localities along the western coast of India was studied by starch-gel electrophoresis. Out of 19 loci scored, no locus was polymorphic by the 95% criterion. Seven loci were polymorphic at the P=0.99 level. The average heterozygosity ranged from 0.6% to 0.9%. These values are very low compared with those of other marine fish species.

### Introduction

The Indian oil sardine, Sardinella longiceps Val. (Clupeidae), is an important species, contributing nearly a third of the total marine fish production of India in productive years (Bal and Rao 1984). Besides its usefulness as a table fish, it serves as a source of valuable by-products such as sardine oil for industry, fish-meal for cattle and poultry feed, and fertilizer for coconut, coffee and tea plantations. Its importance as a highly lucrative fishery in India is restricted to the southern and central regions of the western coast of India. S. longiceps occurs along the coasts of Somalia, Kenya, Seychelles, Gulf of Aden, Red Sea, Gulf of Oman, Persian Gulf, Pakistan, India, Sri Lanka, Andaman Sea, Malaysia, Indonesia, Philippines and Vietnam (Nair and Chidambaram 1951; Bal and Rao 1984).

Past studies of the species have concerned: size at first maturity (150-160 mm) (Antony Raja 1964; Bensam 1964; Dhulkhed 1964); spawning season (June to October) and spawning habits (fractional: once in a season, twice in a lifetime) (Antony Raja 1964); fecundity (about 38 000 ova per adult female and 750 million ova per tonne of adult female biomass) (Antony Raja 1964; Balan 1965); and age and growth (150-160 mm at the end of the first year, 170-180 mm at the end of the second year, and up to 220-229 mm thereafter) (Antony Raja 1970). The species is chiefly a surface/column filter-feeder on phytoplankton, with the feeding intensity depending on the relative abundance of food (Nair 1953; Dhulkhed 1962). Biometrical analysis of morphometric and meristic characters of S. longiceps specimens from Madras on the eastern coast of India and from several places on the western coast revealed a stability of the main external characters that suggested an absence of local races or brood differences (Hornell and Nayudu 1924). On the other hand, Davanesan and Chidambaram (1943) found different head lengths and tail lengths between samples from Aden, Muscat, Bombay-Karachi, Karwar and Malabar; they concluded that the Karwar specimens, which had the longest heads and the shortest tails, belonged to a distinct race and that the Aden specimens represented another race. Nair and Chidambaram (1951) suggested that this aspect requires further careful examination because the existence of distinct races in the oil sardine. if proved conclusively, has an important bearing on their biology and fishery.

Stocks of various species of fishes have been defined by geographic differences in meristic and morphological characters, by regional differences in population parameters, by physiology and behaviour, by the results of tagging experiments, and by physical oceanographic features (Ihssen *et al.* 1981; Iles and Sinclair 1982). With the development of protein electrophoresis and the restriction enzyme analysis of DNA, it has become possible to search for genetic differences between putative stocks that have been defined by non-genetic methods (Spanakis *et al.* 1989).

Electrophoresis of proteins has been widely applied in studies of genetic variation in fish populations (e.g. Stahl 1987; Menezes *et al.* 1990*a*; McElligott and Cross 1991); the fact that each protein is encoded by a single gene allows the identitification of one or more loci with alleles and, hence, a description, useful for management, of the genetic structure of a population (Ryman and Utter 1987; Seeb *et al.* 1990). This paper is an initial attempt to estimate the degree of genetic variation, at protein-coding loci detected by electrophoresis, in *S. longiceps* from three localities along the western coast of India and to determine the structure of the population.

### Materials and Methods

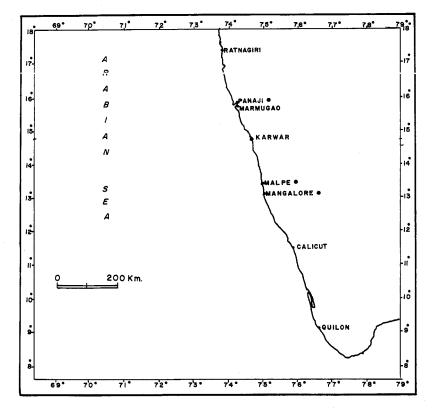


Fig. 1. Map of the western coast of India, showing sampling localities ().

Specimens of S. longiceps were collected from the fish landing centres of Panaji (Goa) in December 1988, October 1990 and January 1991 and Malpe and Mangalore in January 1989 (Fig. 1). The fish were kept frozen at  $-20^{\circ}$ C prior to analysis. The skeletal muscle, liver, heart and eye were dissected from individual specimens. The cell lysate obtained by freezing and thawing was subjected to starch-gel electrophoresis after the method of Menezes and Taniguchi (1988). The buffer system used was citric acid-aminopropylmorpholine at pH 6.0 (Clayton and Tretiak 1972). Detection of isozymes and locus nomenclature (Table 1) followed Shaklee *et al.* (1990).

Allelic variants were designated according to their relative mobility, the most common allele being designated 100 and other alleles being given numbers that indicated their mobility relative to that of the most common allele. Genetic identity and distance were calculated from the formula proposed by Nei (1972). Hardy-Weinberg statistical analysis followed Hartl (1980). Average heterozygosity was determined by summing the number of observed heterozygotes for each locus, dividing this by the total number of individuals in the samples, and averaging over all loci.

## Results

Of the 19 loci detected from 10 enzymes, a general protein and haemoglobin, no locus was polymorphic by the 95% criterion. No locus showed sufficient variation to be of use in the analysis of population structure. However, seven loci were polymorphic at very low degrees of variability.

The genetic variabilities observed in S. longiceps from the three localities and in the total pooled sample are given in Table 2. Among the loci investigated, polymorphism  $(P \leq 0.99)$  was observed for five  $(G3PDH-1^*, IDHP-1^*, MEP^*, PGDH^* \text{ and } AAT^*)$  in the Panaji sample, three  $(LDH-B^*, G3PDH-1^* \text{ and } G3PDH-2^*)$  in the Malpe sample, and two  $(IDHP-1^* \text{ and } PGDH^*)$  in the Mangalore sample. Allele frequencies and  $\chi^2$  values for the differences between observed and expected Hardy-Weinberg numbers of phenotypes of

each polymorphic enzyme are given in Table 3. Genotypes for the samples from the three localities conformed to Hardy-Weinberg proportions (P > 0.05) at all loci. This suggests that all the *S. longiceps* samples were collected from a single Mendelian population.

The allele frequencies were similar at all loci (Table 3). The genetic distance was zero.

#### Discussion

Genetic studies of most epipelagic marine fishes generally show little genetic subdivision within the range of a given species. In addition, sardines have a number of behavioural characteristics that tend to reduce their speciation rates (Parrish *et al.* 1989).

The best estimate of genetic variation in natural populations is the average heterozygosity (H) per locus (Allendorf and Utter 1979). The values of P and H vary non-randomly between loci, populations and species. To avoid serious error in the estimation of average heterozygosity, a large number and wide range of isozyme loci should be examined (Allendorf and Utter 1979). On the basis of 19 loci, the average heterozygosity per locus was  $0.006 \pm 0.011$  (Panaji),  $0.009 \pm 0.020$  (Malpe) and  $0.006 \pm 0.017$  (Mangalore), compared with  $H=0.066\pm0.11$  for the Indian mackerel, Rastrelliger kanagurta (Menezes et al. 1990b),  $H=0.051\pm0.034$  calculated by Nevo (1978) as the mean for 51 species of fishes and  $H=0.048\pm0.039$  as the mean for 82 species of fishes calculated by Winans (1980). High degrees of genetic variation (H=0.056 to 0.106) are also found in marine species of the order Clupeiformes (see Smith and Fujio 1982). The estimate of H=0.106 for the small clupeid fish Clupea harengus is above average (Altukhov et al. 1974). High heterozygosities might be a feature of the pelagic clupeids or of small fish in general (Selander and Kaufman 1973; Valentine 1976). Pacific sardines, however, showed little genetic variation both within and between populations (Hedgecock et al. 1989); in a study of 32 allozyme-coding loci the average heterozygosity ranged from 0.5% to 1.6%, results similar to those of the present study. Slightly greater heterozygosities were found in Spanish sardines off Florida and Brazil, ranging between 2.0 and 2.7% (Wilson and Alberdi 1991). It is probably reasonable to assume that the degree of isozyme variation reflects the relative degree of genetic variation found at other loci in the genome (McAndrew and Majumdar 1983; Menezes et al. 1993). Smith (1986) reported evidence of comparatively low degrees of electrophoretically detectable allelic variation in shark species representing several different orders. He postulated that bottlenecks in previous populations (i.e. reductions in the small numbers of breeding individuals) might reduce allelic variation in species.

Genetic diversity, expressed either as average number of alleles or as average heterozygosity, is usually higher in species with wider geographic ranges, higher fecundity, greater longevity, and larger population sizes (Nevo *et al.* 1984). Soule (1976) identified population size as the most important variable in population genetics theory and long-term maintenance of a large population size as a necessary condition for greater variability.

The abundance of oil sardines in the fishery off India, as revealed by landings, is subject to wide fluctuations that were first noticed by Day (1865). Scarcity of oil sardines has been attributed to indiscriminate capture of immature fish during years of abundance (Raj 1934-40), overfishing (Devanesan 1943), capture of spawning fish during the breeding season (Chidambaram 1950), unfavourable surface temperatures (Chidambaram 1950; Nair 1953), and low availability of *Fragillaria oceanica* (Nair 1953; Nair and Subrahmanyan 1955), which is the preferred food of the oil sardine.

A greatly reduced population size for a single generation can have a dramatic effect on genetic variation (Crow and Kimura 1970). With the loss of genetic variability, the population may no longer be able to exploit its former ecological niche (Ryman 1981). The low genetic variation in Pacific sardines was attributed to a small number of founders rather than to a subsequent bottleneck (Hedgecock *et al.* 1989). Seeb *et al.* (1990) indicated that there was no measurable loss of genetic variability in the spiny lobster, *Panulirus marginatus*, despite fishing pressure over seven years. Early records of oil sardine landings are not available; however, data given by Nair and Chidambaram (1951) on sardine products such as cured fish, oil, fertilizers and fish-meal indicate the extreme annual fluctuations seen in the fishery. A reduction in population size in the past, due to commercial exploitation, might thus explain the present low genetic variation in the Indian oil sardine, *Sardinella longiceps*.

The need for conservation and management of genetic resources has been recognized by fishery scientists for some time, especially in relation to the overfishing of natural stocks and the effects of large-scale changes to aquatic systems (Anon. 1981; Gross 1991). As Ryman (1991) has pointed out, genetic variability should be conserved, so that a population may maintain its potential to respond to environmental perturbations.
