# Significantly dominant warm-core eddies: an ecological indicator of the basin-scale low biological production in the Bay of Bengal

#### Abstract

This paper introduces the cumulative impact of cyclonic (cold-core) and anticyclonic (warm-core) eddies on the distribution of phytoplankton biomass in the Bay of Bengal (BoB).Estimations of the ocean surface eddy features in the BoBusing satellite-derived monthly,seasonal, andmulti-year (2012-2016) datasets showed significant dominanceof warm-core featuresover the cold-core ones. Multi-year monthly dataof the BoBevidenced strikingly higher geographical area (%) for warm cores (av.  $16.5 \pm 5.5$ ) compared to the cold-core features (av.  $2 \pm 1.2$ ). The highest warm-core extent (%) was in May (av.  $25.8 \pm 1.4$ ), followed by April (av.  $22.6 \pm 1.4$ ), February (av.  $19.5 \pm 0.3$ ) and March (av.  $18.3 \pm 0.9$ ).Contrastingly, a relatively higher extent(%) of coldcoresoccurred in November (av.  $3.9 \pm 2.2$ ), October (av.  $3.78 \pm 2.0$ ), and December (av.  $3.5 \pm 2.1$ ). The analysis also showedthat the extreme oligotrophy of the study domain during the Pre-Monsoon (March-May) was caused by a robust, warm gyre.Upwelling and winter convection, whichenhances phytoplankton biomass in the Arabian Sea, are either very weak or absent in the BoB. Similarly, nutrient inputs through river influxinto the BoBare insufficientto enhance phytoplankton stock beyond the shelfwaters. In this scenario, we showed herethat the significantly larger spread of warm-core over the cold-core eddies is a simpleecological indication of thebasin-scale low phytoplankton stockin the BoB.

## 1. Introduction

Bay of Bengal (BoB) is a large oceanic basin in the north-eastern section of the Indian Ocean and has low phytoplankton biomass and production compared to the adjacent Arabian Sea (Prasannakumar et al., 2002; Gauns et al., 2005). Eddiesare very common in the BoB, anoutcome ofpeculiar coastal geometry, circulation, and remote forcing (Cheng et al., 2018). They can play an essential role in plankton distribution as they modify the vertical distribution of physicochemical parameters (McGillicuddy et al., 1998; 2003; Flierl and McGillicuddy, 2002; Batten and Crawford, 2005; Mackas and Coyle, 2005; Strzelecki et al., 2007; Feng et al., 2007).Both cyclonic and anticyclonic eddies exist in the BoB, in which the formerincreases the phytoplankton biomass through divergenceand associated nitrate restoration in the surface waters. In contrast, anticyclonic eddies decrease the phytoplankton biomassthrough surface water convergence and nutrient impoverishment (Prasannakumar et al., 2004, 2007; Jyothibabu et al., 2008; 2015).

The topic of eddies in the BoB,concerning the phytoplankton biomass distribution,has caught the attention of researchers fairly recently,emergingas a prominent area of interestwithin the last two decades (Prasannakumar et al., 2004, 2007; Vinayachandran and Simi Mathew, 2008; Vidyaand Prasannakumar, 2013; Jyothibabu et al., 2015). However, standard *in-situs*tudies on the distribution of phytoplankton biomass were in place sincethe 1960s (Bhattathiri et al., 1980; Gomes et al., 2000; Prasannakumar et al., 2002; Gauns et al., 2005;Madhu et al., 2006).The standard message in these*in-situ* studies is that the BoBbasin has low phytoplankton production except in the regions adjacent to its western and northern boundaries. There are some studies oncyclonic (cold-core) eddies from the BoB showing that such eddies cause enhancedphytoplankton stockin the BoB, and proposed further that such eddies are the naturalmechanism to enhance biological production (Prasannakumar et al., 2004, 2007; Vidya and Prasannakumar., 2013). Remarkably, no previous studies have accounted for the contribution of the numerous anticyclonic (warm-core) eddies existing in the BoBthroughout the year.Further, the collective effect of cold-core and warm-coreeddies on the phytoplankton biomass production and distribution in the regions still lacking.

Studies in the past showed that he seasonal ocean processes that make the Arabian Sea productive (coastal upwelling during the Southwest Monsoon and winter convection during the Northeast Monsoon) are either absent or very weak in theBoB (Table 1; Gomes et al., 2000; Jyothibabu et al., 2002 & 2008; Gauns et al., 2005). Also, river inputs are not sufficient toenrich nutrient levels beyond the narrow shelf waters in the BoB(Sarin et al., 1989; Prasannakumar et al., 2002; Jyothibabu et al., 2008., Krishna et al., 2015; Sarma et al., 2016). The ocean surface layers in the BoBhave low-nutrient throughout situations, eddies could the year. Insuch govern the distribution of nutrients and, thereby, the overall plankton production. Therefore, we propose the idea that the cumulative effect of the two kinds of eddies governs the basin-scale distribution of phytoplankton biomass in the BoB. To investigate this idea, we assessed the relative geographical extent of cyclonic and anticyclonic eddies in the BoBover different scales (monthly, inter-seasonal, and inter-annual). It also proposed the cumulative impact of these two kinds of eddies on the phytoplankton biomass distribution in the BoB imprinted in the past in-situ studies.

#### 2. Methods

The sampling domain in the BoB wasselected 1° far from the coastline to avoid any possible interaction from coastal inputs over the eddy-infested regions (Figure 1). Relevant satellite datasets from online sources presented the oceanographic setting in the sampling domain (7.99°N - 20.96°N; 80.8°E - 92°E). Weekly datasets of Mean Sea Level Anomaly (MSLA.) and geostrophic currents were retrieved for five years(2012 - 2016) from Archiving Validation and Interpretation of Satellite Oceanographic (AVISO) live access server (aviso.altimetry.fr). The spatial plots of MSLA were overlaid with geostrophic currents to identify eddies/gyres following the criteria of  $\pm 10$  cm of MSLA along with the circular pattern of geostrophic currents and closed contour lines (Chaigneau et al., 2008; Vinayachandran, 2009). The identified eddy features were additionally verified through manual validation ensure the accuracy of the information generated. The area of eddy/gyre infestation was calculated from the number of pixels covering the selected sampling domain. The weekly datasets were processed to obtain monthly, seasonal, and annual scale variation of the respective parameters. Phytoplankton biomass (chlorophyll a) data were retrieved from MODIS-AQUA through NASA's Giovanni web server (giovanni.gsfc.nasa.gov). Open-source applications such as Pyferret (ferret.pmel.noaa.gov), R (rstudio.com), QGIS (qgis.org), and ODView (odv.awi.de) were used in this study for data extraction, analysis and presentation purposes. Statistical analyses such as normality tests and Wilcoxon pairwise comparison of the data differences was conducted in R-Studio (version 1.2.5001)

# 3. Results and Discussion

An estimate based on satellite data showsthat numerous eddiesexistin the western and central BoB (Figures 2& 3). Eddy formation along the Indian coastline in the BoBis the result of baroclinic instability of the East India Coastal Current (Kurien et al., 2010; Cheng et al., 2013, 2018; Chen et al., 2018). Conversely, remote forcing by equatorial winds through the generation of Kelvin wave is the primarycause behind the eddy generation in the central BoB(Cheng et al., 2013; Chatterjee et al., 2017).From March to September [Pre-Monsoon (March-May) and Southwest Monsoon (June -

September)], a sizeable warm gyre occupiesa significant part of the western BoB. In contrast, a cold gyre of relatively less geographical extent fills the South-western BoB during November-December (Northeast Monsoon) (Figure 2&3). It appears that the large warm gyre in the study domain is the main reason for the extreme oligotrophy of the western BoB during the Pre-Monsoon(Gomes et al., 2000; Madhu et al., 2006) and noticeably low productivity during the Southwest Monsoon (Prasannakumar et al., 2002; Madhu et al., 2006).

Althoughcyclonic (cold-core) eddies typically increase the phytoplankton biomass production in the surface waters through upwelling of nutrients from the subsurface, the same is not always right for BoB, especially in regions where strong low-saline surface water stratification prevails. In such areas, cold-core eddies were unable to break the low salinity stratification of the top 20m surface layer, thereby curtailing their effects only to the subsurface waters (Prasannakumar et al., 2007; Jyothibabu et al., 2008). This peculiar oceanographic feature in the BoBis the reason for the cyclonic eddy-induced enhanced chlorophyll biomass misses out in satellite imageries (Jyothibabu et al., 2015). The cold-core eddies in the BoBcan certainly increase phytoplankton biomass, but prominently in the subsurface waters. However, this enhancement in phytoplankton biomass, which is relative to the severe oligotrophic conditions in the adjacent regions, is rather moderate in quantitative terms when compared to the coastal upwelling or winter convection regions of the Arabian Sea (Jyothibabu et al., 2015).Importantly, this situation may change in the southern BoBduring the Northeast/ Winter Monsoon, where surface salinity stratification is the weakandmoderate enhancement in phytoplanktonbiomass occursin the surface waters under the influenceof agiant cold (Vinayachandranand Simi Mathew, gyre 2008).However,thisenhancedphytoplankton biomass concentration, even in the south-western BoBduring the Northeast monsoon associated with the cold gyre, is moderate. It is much lower than the winter bloom situation in the northern Arabian Sea (north of 16°N) due to winter convectionor upwelling situation along the Southwest coast of India during the Southwest Monsoon (Figure 4).In essence, cold-core eddies are the mechanism enhancing phytoplankton biomass production in the BoB, making the otherwise oligotrophic region moderately productive (Jyothibabu et al., 2008; Prasannakumar et al., 2004, 2007). Due to the presence of several warm-core and core-eddies in the Bay of Bengal, the vertical distribution of nutrients shows some general spatial variations i.e., a deepening of isolines of nutrients in warm-core and a shallowing in the cold-cores (Jyothibabu et al., 2017). A recent study by Sarma et al., (2018)presented the vertical distribution pattern of macronutrients (nitrate, phosphate and silicate) in the western Bay of Bengal infested by warm-core and cold-core eddies. The warm-core eddies very clearly decreased the concentration of all macronutrients in the upper euphotic column compared to the non-eddy regions. For eg, the isoline of  $0.5 \mu$ M of nitrate, which was situated at 30m depth in the non-eddy region was found at much deeper depths (50 to 60m) in warm-core eddy regions. This essentially shows the surface water convergence in the warm-core eddy regions, which cause extremely nutrient-depleted surface waters occupying the upper euphotic column leading to low phytoplankton biomass production.

The spatial distribution of cold and warm-core features in the BoB evidenced the occurrence of avery prominent warm gyre, which is attributable to the extreme oligotrophy of the western BoB during the Pre-Monsoon (Gomes et al., 2000; Madhu et al., 2006) and noticeably low production during the Southwest Monsoon (Prasannakumar et al., 2002; Madhu et al., 2006). Considering the numerous cold-core and warm-core eddies in the BoBand their role in altering thespatial distribution of phytoplankton biomass, their cumulative impact could berather useful to explain the overall biological production. The month-wise analysis of the relative dominance of warm cores and cold cores in the study domain showed a more significant percentage of the geographical extent for warm-core areawas in May (av.  $25.8 \pm 1.4$ ), followed by April (av.  $22.6 \pm 1.4$ ), February (av.  $19.5 \pm 0.3$ ) and March (av.  $18.3 \pm 0.9$ ). On the other hand, though the cold-core geographical extent was significantly lower, their relatively high percentage extent was found during November (av.  $3.78 \pm 2.0$ ), and December (av.  $3.5 \pm 2.1$ ). The pairwise comparison (Wilcoxon test) showed that the area of the warm-core eddy was significantly higher than the area of cold-core eddy (p<0.001) throughout the sampling period.

Season-wise analysis of the percentage contribution of warm-core and cold-core features in the study domain showed significant domination of the former. The percentage contribution of warm-core was the highest during the Premonsoon (av.  $22.2 \pm 1.3$ ), followed by the Southwest Monsoon (av.  $6.9\pm 1.2$ ). On the other hand, the percentage of cold-core was relatively high during the Southwest Monsoon (av.  $6.9 \pm 1.2$ ), followed by the Northeast Monsoon (av.  $2.2 \pm 2.1$ ). The percentage contribution of cold-core and warm-core features in the study domain showed some inter-annual variability when considered the 5 years (2012-2016). But thewarm coressignificantly dominated over cold-core features in all the five years considered here. The percentage contribution of the warm-core region was the highest in 2016 (23.4) compared to the rest of the years (Figure 5). The dominance of warm-cores in the context of a changing ocean warmingpauses the possibility of nutrient impoverishment in the ocean surface waters in the future. Given such a future scenario, the dominant warm-core features in the BoB may have negative implications such as a significant

decrease in the basin-scale phytoplankton biomass and thereby, an increase in the severity of oligotrophy.

Eddies persistent for days to months are common in the BoB, and they are mostly mobile features drifting several 10s to 100s of kilometres during their life span between formation and dissipation (Jyothibabu et al., 2015; Jagadeesan et al., 2019). There are many eddies in the BoB that remain rather stable an area and persist for several months; clearly, these eddies are genuinely influential in altering the plankton production in such regions. The age of eddies is anotheressential aspect to be looked at in a biological context as a time lag always exists between the ocean physical processes and its manifestations on the biological production in different trophic levels (Jagadeesan et al., 2019). Prolonged(mature) eddies that are consistent for several months can undoubtedly alter the biological and biogeochemical features in isolated regions of the BoB (Vidya and Prasannakumar, 2013; Jyothibabu et al., 2015; Jagadeesan et al., 2019). The persistent cold-core eddy situated for several months in the central-western BoBis the main reason for the higher than expected level of vertical biogenic fluxobserved there in the sediment traps (Vidya and Prasannakumar, 2013). Similarly, the prolonged cold gyre in the South-western BoB during the Northeast Monsoon period could enhance phytoplankton biomass production (Vinayachandran and Simi Mathew, 2008). Likewise, protracted warm-cores in the BoB have an inducing impact on the formation of *Trichodesmium* blooms, and such blooms channel large amounts of molecular nitrogen into the ocean (Jyothibabu et al., 2017)

It is assessed here whether the past *insitu* studies hasgenuinely represented the basin-scale scenario of phytoplankton biomass distribution in the BoB.These studies necessarily presentBoB with relatively low phytoplankton biomass production (Figure 6). The only criticaldifference between these studies is in finding out the crucial causative factor responsible for observing the low plankton production in the BoB. Before Gomes et al. (2000), the general belief was that the low underwater solar radiation due to the massive sediment influx and heavy cloud cover is the most important causative factor for the low phytoplankton production in the BoB. Gomes et al., (2000) and later studies have shown that it is the nitrate limitation in the surface waters due to the stable low-salinity stratification as the main causative factors for the observed low phytoplankton biomass production in the BoB. It was observed in this study that nitracline (1µm concentration of nitrate) was situated very deep (~60m) in the water column during the Pre-Monsoon period, which is characterised by extensive warm gyre in the entire western Bay of Bengal.

Nonetheless, the general message in all these studies is the low phytoplankton biomass production in BoB (Table 2), and here, the most valid question is that how such a consistent signature reflects in all those past studies and how realistic they are?A close observation of the sampling points in the historical studies would suffice to answer the above query (Figure 6). Even though the ocean mesoscale processes and their implications were unknownduring those periods, the widespread,somewhatrandom distribution of sampling points in the historical studies would have allowed them to account the impact of both the warm-core and cold-core features existing during that period. In essence, it seems thatthe earlier*in-situ*studies have reasonably accounted forthe biological impacts of randomly distributed cyclonic and anticyclonic features. Hence,the general idea of the phytoplankton biomass production in the BoBpresented in them seems to be realistic and consistent from an oceanographic standpoint.

## 4. Conclusion

This study corroborates the view that the basin-scale nitrogen limitation in the surface waters arising from the strong low-saline stratification, lack of upwelling, and absence of winter convection are the primary causes behind the low phytoplankton biomass production in the BoB. The proposition in a few more recent studies that ocean surface eddies are the mechanism that enhancesphytoplankton production in the BoB looks to be incomplete and unrealistic. Mostly, this proposition ismisleading, asboth cyclonic (cold core) and anticyclonic (warm core) features are numerous and co-occur in the region. Considering only the cold-core features and highlighting them to draw generalconclusions on plankton production pattern in the BoBhave an inherent scientific flaw. Therefore, estimations were carried out hereabout he extent of ocean surface eddy features in the BoBon a monthlyscale over a multi-year (2012-2016) period, using satellite datasets. Thisstudy evidenced strikingly higher geographical area (%) for warm cores (av.  $16.5 \pm 5.5$ ) compared to the cold cores (av.  $2 \pm 1.2$ ). And concludes that cold-core eddies could certainly enhance the phytoplankton biomass production in some secluded regions in the BoB. But, the cumulative impact of warm-core and cold-core eddies in the BoBis negative on the basin-scale phytoplankton biomass production due to the significant dominance of the former regardless of the seasons. Therefore, we propose that the predominance of warm-cores can be considered as an environmental indication of the basin-scale oligotrophy of the BoB.
